### Confidentiality & Data Protection Guidelines

**Our Commitment to Your Privacy:** Pharma Launchpad is dedicated to maintaining the confidentiality of your personal data. It is our fundamental practice to respect your digital footprint and protect any details we gather during your use of our platform.

#### 1. Scope of This Policy

### **3. Cookies and External Content**

- **Temporary Session Cookies:** We use transient cookies to facilitate your current visit or manage a transaction. These files expire automatically when you leave and do not monitor your behavior on other websites.
- **Outbound Links:** Our platform may contain links to independent third-party websites. We are not responsible for their content or privacy standards and suggest you review their individual policies.
- **Embedded Media:** Content such as videos or articles from external sources may track your interaction as if you were visiting their original site, particularly if you are logged into an account with those providers.

### **4. Community Feedback and Data Retention**

- **Public Comments:** When you post a comment, we record the data in the form as well as your IP address and browser type to prevent fraudulent activity.
- **Comment Persistence:** Published comments and their associated metadata are archived indefinitely to streamline the approval of future responses.
